CIH CM Credit, 2020 MRASH Conference, November 17 – 20, 2020

The content of this week's session has been reviewed with the Educational CM category for CIH certification maintenance. The topics below have been mapped to content eligible for CM credit, namely to:

- IH: Topics fitting these classic IH rubrics of: Air Sampling, Analytic Chemistry, BIOHAZARDS, Ventilation, Ergonomics, Health risk analysis/HazCom, IH Program Management, Noise, Respirators/PPE, Radiation, Heat/Cold, Toxicology, Work Environments/Industrial Processes (hazards associated with general processes)
- Ethics: Topics such as fairness, honesty, truthfulness, integrity, accuracy, objectivity, confidentiality, compliance, legality, conflicts of interest, conflict management, undue influence, equal opportunity, diversity, intellectual property rights/plagiarism, use of certification marks and professional competency/limitations (i.e., when to refer a client
- Management: General management training, including Leadership, addresses skill development which is generically applicable to many professionals, not just IH professionals, e.g., communication techniques, technical writing, presentation techniques, organizational effectiveness, media training, computer skills, supervisory skills, quality training, financial or accounting training, expert witness training, project management.
- Safety: The subject matter is more acute hazard oriented and not included in the IH CM Area. For example, Safety CM credit can be claimed for guarding, electrical hazards, fall protection, workplace violence or physical security. Note: Confined Space Entry is considered to be the IH CM area. Per Board legacy rule, First-Aid, CPR and AED classes are **not** eligible for CM credit.

Note that with the exception of "ETHICS" there must be at least one hour of content (can't use 30 min), so you must attend the full hour of a two-part session to claim that 0.167 point.

The following sessions have been determined to meet the credit as follows:

Tuesday:	3 hours, IH (Biohazards) – 0.5 CM max		
Wednesday:	2 hours, Management – 0.334 CM max		
Thursday:	1 hour IH, 1 hour Safety, 1 hour Management (see below)		
Friday:	2 hours Management, 1 hour Safety		
(Note: CIHs are allowed only 5 Management points per cycle)
